Dear Sir, Madam,

With reference to your application dated 27/01/2021 and subsequent correspondence with the school / inspection in this regard, I convey the grant for provisional recognition to the Saint Capitanio Sr. Sec School, Kuarpar, Near N.I.T, Silchar for Class I to Class VIII for the period of three years w.e.f. 20/02/2021 to 19/02/2024.

The above sanction is subject to fulfilment of following conditions

1. The Grant for recognition is not extendable and does not in any way imply any obligation to recognized/affiliate beyond class VIII.
  2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2010 (Annexure II)
  3. The school shall admit in class I to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group I the neighbourhood and provide free and Compulsory elementary education till its completion Provided. Further that in case of pre-primary classes also, this norm shall be followed.
  4. For the children referred to in paragraph 3, school shall be reimbursed as per section 12(2) of the Act To receive such reimbursements school shall provide a separate bank account.
  5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
  6. The school shall not deny admission to any child for lack of age proof, if such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion case of race, place of birth or any them.
  7. The school shall ensure
    - a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
    - b) No child shall be subjected to physical punishment or mental harassment.
    - c) No child is required to pass any board examination till the completion of elementary education.
    - d) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
- Inclusion of students with disabilities/special needs as per provision of the Act.



- g) The teacher performs its duties specified under section 24(1) of the Act an.
- h) The teacher shall not engage himself or herself for private teaching activities.
8. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
10. The school shall maintain the standers and norms of the school specified in the section 19 of the Act. The facilities reported at the time of last inspection are as given under
  - Area of School campus
  - Total built up area
  - Area of play ground
  - No of class rooms
  - Room of Head Master-cum Office-cum storeroom.
  - Separate toilet for boys and girls
  - Drinking water facility
  - Kitchen for cooking mid
  - Barrier free Access
  - Availability of Teaching Learning Material/Play Sports Equipments/Library
11. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
12. The school buildings or other structures or the ground fare used only for the purpose of education and skill development.
13. The school is run by a society registered under the societies Registration Act 1860(21 if 1860) of a public trust constituted under any law for the time being in force
14. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy of each of the Statements of Accounts should be sent to the DEEO every year.
15. The recognition Code Number allotted to your school is DEO/Rec/Private/03/21.
16. The school furnishes such reports and information as may be required by the Director of Elementary Education/ District Elementary Education Officer from time and complies with such instruction of the state Government/Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiency in working of the school.
17. Renewal of Registration of Society if any be ensured.
18. Other condition as per Annexure III enclosed.
